In the absence of student feedback, the assessment of the Applicant's direct supervisor is also acceptable.</p> <div><p>¹Foreign Applicants: 400 contact hours (of which at least 50 hours of lectures) are the minimum requirement, maximal additional points can be awarded for another 400 contact hours (of which 50 hours are lectures). Instead of the Applicant's superior certifying the contact hours taught, other means of proof used in the particular country are also admissible.
