The teaching activity must be certified by the Applicant's direct superior, and the relevant student feedback results for at least the last 5 years must be provided. In the absence of student feedback, the assessment of the Applicant's direct superior is also acceptable.</p> <p><u>Special criteria for the minimum requirement:</u> Experience in higher education may include lectures, seminars, practice sessions, consultations and, in case of summer practice, sixth-year practice and tutorial activities in vocational education and training, an additional two contact hours per week, irrespectively of the number of students. At least 100 hours of the latter must fall within the five years preceding the submission of the application.</p> <div style="border: 1px solid black; padding: 5px;"> <p><u>¹In the case of foreign Applicants:</u> instead of the Applicant's superior certifying the contact hours taught, other means of proof used in the particular country are also admissible. For example, a certificate from the dean's office, or an itemised list of the courses which yielded the contact hours stating the course titles, the name of the institution/faculty/subject, the level of education (bachelor, master, doctoral), and the date.</p> <p>With respect to student feedback on teaching activity, the information resulting from the processes of the given country must be taken into account.</p> </div>	10

Recognised international publisher refers to a domestic or international publisher that has a peer reviewed international journal classified as Q1 or Q2 or recognised by the scientific committees of the Hungarian Academy of Sciences, or has peer reviewed publications/book series on technical subjects with a high rate of citation in the field. In fields where classification of journals as Q1 or Q2 is not relevant, papers published in peer reviewed international journals that are leading journals in the relevant discipline of science and are accepted by the scientific committees of the Hungarian Academy of Sciences and listed on the website of the Doctoral Council of the Hungarian Academy of Sciences, may also be taken into account. The Applicant must be the sole author of at least one peer reviewed monograph, which must be different from the Applicant's PhD dissertation (this may be the same as the monograph mentioned under the common criteria applicable to all disciplines).</p> <p>Peer reviewed papers are papers that are at least about 8 pages (about 20,000 characters) long, are classified as 'scientific works' in the MTMT database, include notes and citations to technical literature, and are not listed in the lines 'conference proceedings' or 'other scientific works' in the summary table of the MTMT. The category does not include editor's foreword, essays, or reviews of books or journal articles.</p> <p><u>Special criteria for the minimum requirement:</u> The Applicant must be the author of at least 48 peer reviewed papers, including at least ten peer reviewed papers written in a foreign language and published in a peer reviewed volume or journal.
