<p><b>Minimum requirement* (10 points):</b> The Applicant is required to have taught at least 800 contact hours (including at least 100 hours of lectures) at any higher education institution during the ten active years preceding the submission of the Application. The teaching activity must be certified by the Applicant's direct superior, and the relevant student feedback results for at least the last five active years must be provided. In the absence of student feedback, the assessment of the Applicant's direct supervisor is also acceptable.</p> <p><b>Special criteria for the minimum requirement:</b> Experience in higher education may include lectures, seminars, practice sessions, consultations and, in case of summer practice, sixth-year practice and tutorial activities in vocational education and training, an additional two contact hours per week, irrespectively of the number of students. At least 100 hours of the latter must fall within the five active years preceding the submission of the application.</p> <div style="border: 1px solid black; padding: 5px;"> <p><sup>1</sup><b>Foreign Applicants:</b> proof of contact hours does not need to come from the Applicant's direct superior. Instead, other acceptable forms of verification from their country can be used. For example, this might include a certificate from the dean's office or a detailed list of courses making up the contact hours, which must include the course titles, the institution/faculty/subject names, the level of education (bachelor, master, doctoral), and the dates. With respect to student feedback on teaching activity, the information resulting from the processes of the given country must be taken into account.</p> </div>	10	
<p><b>Points for teaching activities:</b> 20 points are given for 1000 contact hours, 30 points for 1200 contact hours, 40 points for 1400 contact hours, and 50 points for 1600 contact hours.</p> <p>For educational performance (1a.1.), the minimum requirement is 800 contact hours (including 100 hours of lectures), for which the Applicant is given 10 points.</p>	40

<p>Outstanding scientific work is assessed on the basis of the minimum requirements set by the Hungarian Academy of Sciences (Section II Philosophy and Historical Sciences, including Psychology) regarding applications for the title Doctor of the Hungarian Academy of Sciences in the two relevant fields (social sciences and natural sciences). The Applicant shall clearly indicate which set of criteria of the two different psychological fields (natural sciences and social sciences (hereinafter respectively A and B) he/she will you choose to assess their outstanding scientific and research work.</p> <p><b><u>Minimum requirement* (10 points):</u></b> 75% of the requirements indicated above must be met.</p> <p>A) In the case of <i>Natural Sciences</i>: The expected professional impact of scientific output is a minimum of 180 PsychInfo, Medline, Scopus or SCI citations over a career and a Hirsch index, calculated on the basis of independent citations, of at least 9 based on these citations (i.e. the number of scientific publications with independent citations greater than/equal to the Hirsch index), and a minimum cumulative impact factor of 45.</p> <p>B) In the case of <i>Social Sciences</i>: At least 90 points based on the scoring system in the table below and at least 180 citations based on the MTMT database: In the case of monographs, edited books, book chapters: scientific peer-reviewed monographs/textbooks are publications that have been peer-reviewed (edited) and have an ISBN or ISSN. The monograph/book may be printed, electronic or on CD, but in the latter two cases it must also meet the criteria described above.</p> <p>Monograph – 10 points (12 points for foreign language publications) Edited volume – 6 points (8 points for foreign language publications) Book chapter – 4 points (6 points for foreign language publications) Article in a peer-reviewed Hungarian or foreign language scientific journal – 4 points (6 points in case of foreign language publications)</p> <p>In the case of a Hungarian-language articles, the term "scientific journal" refers to a journal that has an editorial board, the scientific standard of articles are peer-reviewed by anonymous experts and have an abstract in a foreign language. The journal may be printed, electronic or on CD, but in the latter two cases it must also meet the criteria described above.</p> <p>Only journals in PsychInfo, PubMed or Web of Science may be taken into account if the article is in a foreign language.</p> <p>Article published in international conference proceedings – 2 points</p>	10

The maximum score that can be given here is 40 points – a total of at least 240 citations (<math>60 \times 0.67 = 40</math>).</p> <p>B) In the case of <i>Social Sciences</i>: Each point awarded on the basis of scoring system B above the minimum requirement is worth 1.334 points (e.g. for a total of 103 B points, <math>13 \times 1,334</math> can be given, which is rounded up to 17 additional points).
